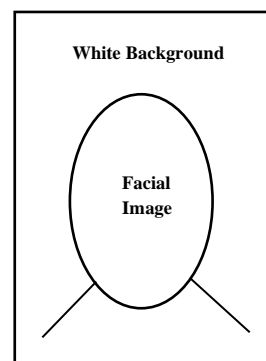


## APPLICATION FOR PASSPORT FOR BHUTANESE LIVING IN AUSTRALIA AND NEW ZEALAND

**PHOTO SPECIFICATION**

The size of the photograph should be 45 mm x 35 mm with your facial image taking up 70 to 80 % of the photograph and the photograph must be:

- a. *white background without border;*
- b. *portrait style with eyes open and forehead & ears clearly visible;*
- c. *without flash reflection, tinted lenses and thick frames if you are wearing glasses;*
- d. *without shadow with sharp and clear focus;*
- e. *of high quality with no ink marks or creases;*
- f. *printed on photo-quality paper for photographs taken with a digital camera;*
- g. *clean with no smudge marks;*
- h. *glued and not stapled or pinned to the application; and*
- i. *not older than six months.*

**DOCUMENTS REQUIRED**

Ensure all the following documents are submitted along with the application:

- a. *Police report in case of lost Passport.*
- b. *Copy of Citizenship Identity Card.*
- c. *Identity document from MoHCA and copy of both parents' Citizenship Identity Card/Resident ID card in case of children without Citizenship ID card.*
- d. *Online Security Clearance Certificate of the applicant has to be valid, but, need not submit it to the Embassy.*
