- 1. The Royal Bhutanese Embassy, in New Delhi invites quotation / seal bids from the interested diplomatic person, voter card holders and non-privileged persons / organizations. Have to pay the duty and taxes to the authorities before taking the property.
- 2. If the bidder is Bhutanese citizen ownership transfer of vehicle shall be approved only to the tenderer who submitted the bid and any applicable transfer tax has to be paid by the buyer to the RSTA Office at the time of ownership transfer as per the RSTA existing rule.
- 3. The vehicle may be inspected at the Royal Bhutanese Embassy, in New Delhi address: Chandra Gupta Marg, Chanakyapuri New Delhi 110021 from 3rd 17th October 2022 between 10:30 am to 04 pm during week days. For appointment you may call 8800220296. It will be assumed that the bidder has inspected the vehicle and is satisfied as per the condition



mentioned above that are bidding for. No inspection shall be allowed thereafter. Complaints of any mismatch of the condition of the vehicle will not be entertained later.

- 4. The tender form can be collected from the Finance Attaché by paying Rs. 300.00 (Three hundred) Non-refundable.
- 5. Single envelope sealed bid must be submitted to the office of the MTO on or before 18th October 2022 at 2:30 pm and shall be open at 3:30 pm on the same day at the Embassy.
- 6. The successful bidder will be required to pay full amount of 25% of the bid amount to the Royal Bhutanese Embassy, New Delhi at the time of acceptance of tender or the balance amount within 10 working days, failing which the offer will be cancelled and the 25% deposit shall be forfeited.
- 7. The bidders shall submit a sealed tender address to "Head of Chancery" along with the Earnest Money of Rs. 20,000.00 (Rupee twenty thousand) only in the form of Cash/DD/Cheque/Cash Warrant addressed to the Head of Chancery, RBE, New Delhi.
- 8. The EMD of the successful bidder will be adjusted against the offer and the EMD of the unsuccessful bidders will be refunded immediately after finalising the winner.
- 9. The earnest money of the successful bidder will be forfeited if he/she refuses to accept the tender.
- 10. If the offer price is less than the reserve price then that particular lot shall be considered as cancelled.
- 11. The successful bidder shall be informed in writing and instruction to deposit the amount as per serial no. 6 above.



- 12. The bidders may attend the tender opening and will be able to witness the opening process and bid prices.
- 13.If there is a tie between bidders then a lucky dip shall be held as "Yes" or "No" to decide the ultimate winner.
- 14. It is mandatory for all the bidders to quote price both in figure and words. In case of discrepancy between the figure and words the words will prevail over figures.
- 15. The tender committee reserves the right to accept or reject the bids without assigning any reason whatsoever.
- 16. The mere acts of submission of tender imply that the bidders accept without question the terms and condition attached.
- 17. The Royal Bhutanese Embassy, New Delhi will deliver the vehicle after completion of all formalities as required by Indian authorities. The successful bidder must complete all necessary transfer formalities with relevant local authorities before taking the vehicle.
